Instructions for Transferring Your Out of State Title with a Lien or Lease to an Ohio Title

1. Complete the attached form letter. This form letter is requesting the lien holder to forward your out of state title and other necessary documentation to our office.
2. Mail or fax the form letter to your lien holder.
3. **A Customer Service Representative will contact you by phone when we have received the documents from your lien holder. Please ensure that you include your phone number.** They will inform you of the documentation that you will need to bring to our office.
4. After we have received the title from your lien holder or leasing company you must bring an **out of state inspection** and your driver's license to one of our offices to apply for the Ohio title. A New Car Dealership or Deputy Registrar will inspect your automobile for you. Deputy Registrars are listed under "License Services" in the yellow pages. The inspection entails verification of the year, make, model and serial number of your vehicle.
 - If the title is in two names, both owners must come in to apply for the Ohio title. An owner may authorize another person to apply for a title on their behalf with a notarized power of attorney. *Note:* If your car is leased, the party appointed power of attorney from the leasing company must apply for the title.
 - For information regarding Ohio license plates or drivers license, contact the Ohio Bureau of Motor Vehicles at (614) 752-7500 or a Deputy Registrar.

The original Ohio Certificate of Title will be returned to the Lien Holder or Leasing Co. upon completion.
