RESOLUTION AUTHORIZING A COUNTYWIDE
CONTRACT WITH **CENTRAL POLY CORP.** FOR
THE PROVISION TO THE SUPPLY AND
DELIVER TRASH BAGS
(FRANKLIN COUNTY GENERAL SERVICES
PURCHASING)

(Est. Annual Amount \$91,111.20)

WHEREAS, competitive sealed bids were received and opened by the Purchasing Department on August 27, 2007; and

WHEREAS, **Central Poly Corp.**, was the lowest and best bidder for the supply and delivery of Trash Bags; and

WHEREAS, the bid documents including the campaign contribution affidavit, specifications, and prices submitted by **Central Poly Corp.**, for ITB 2007-02-12 shall be the governing term contract which is fully incorporated herein, and is binding on both parties; and

WHEREAS, the term of the contract will be for a period of one year beginning November 20, 2006 and will continue through November 19, 2008 with the option to extend for one additional one year period; and

WHEREAS, the Franklin County Department of General Services/Purchasing Department recommends the bid submitted by **Central Poly Corp.**, as the lowest and best bid for the supply and delivery of Trash Bags; now therefore, upon motion of Commissioner Brown, seconded by Commissioner Kilroy,

THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

That the contract with **Central Poly Corp.** in an amount not to exceed the line items bid prices totaling \$91,111.20 is hereby approved.



For
2007-02-12
Trash Can Liners

- ITB# 2007-02-54 to provide Trash Can Liners for Franklin County was competitively bid in accordance with 307.86 of the Ohio Revised Code through the Purchasing Department.
- In addition to being publicly advertised and posted on the Franklin County Bid Webpage, 25 companies believed to be able to service this contract received individual notification that the bid was available.
- The contract requires the supply and delivery of trash bags used throughout various Franklin County facilities.
- The bid opening was conducted on August 27, 2007. Seven bids were received. The bidders were HP Products, Interboro Packaging Corporation, EC Supply Inc., Aetna Building Maintenance, Gordon Food Service, Carmens' Distribution Systems, Inc. and Central Poly Corp. HP Products bid could not receive further consideration as the bid bond was not in the proper form.
- Franklin County Purchasing reviewed the bids to assure compliance to the bid requirements as well as whether the products met the specifications. This was coordinated with Franklin County Public Facilities Management Housekeeping. After the reviews, it was determined that Central Poly Corp. is to be recommended for a bid award as the lowest and best bidder. PFM Housekeeping and other County users of the contract will be given advice on the proper products to use.
- The contract is for a one year period with the option to extend for an additional one year extension period allowing up to a 6% increase at each extension with proper verification.
- A representative of Franklin County Purchasing Department will present the resolution to the Board of Commissioners.
