**FRANKLIN COUNTY
CYBERSECURITY PROGRAM FRAMEWORK STANDARD**

WHEREAS, in accordance with Ohio Revised Code §307.841, the board may, by unanimous consent, adopt such rules and regulations as it deems necessary for its operation; and

WHEREAS, in accordance with Ohio Revised Code §9.64, the Cybersecurity Program Framework Standard attached to and made a part hereof is submitted to the Franklin County Automatic Data Processing Board for review; and

WHEREAS, the Franklin County Data Center Chief Information Officer recommends this framework;

NOW, THEREFORE, BE IT RESOLVED that the Franklin County Automatic Data Processing Board recommends the Cybersecurity Program Framework Standard hereby attached be approved by the Franklin County Board of Commissioners.

Franklin County

Cybersecurity Program Framework Standard

1. Purpose

The standards outlined in this document aim to ensure compliance with the Ohio Revised Code, minimize risk, and enhance governance of Franklin County's cybersecurity program.

2. Authorization

Ohio Revised Code §307.84

... After the initial meeting of the county automatic data processing board, no county office will purchase, lease, operate, or contract for the use of any automatic or electronic data processing or record-keeping equipment, software, or services without prior approval of the board.

Ohio Revised Code §9.64

...The legislative authority of a political subdivision will adopt a cybersecurity program that safeguards the political subdivision's data, information technology, and information technology resources to ensure availability, confidentiality, and integrity. The program will be consistent with generally accepted best practices for cybersecurity, such as the national institute of standards and technology cybersecurity framework, and the center for internet security cybersecurity best practices...

3. Scope

4. Standard

Franklin County's Cybersecurity Program Framework Standard is based on the National Institute of Standards and Technology (NIST) Cybersecurity Framework (CSF) 2.0. This program will implement controls in accordance with the best practices outlined in the Center for Internet Security (CIS) Controls version 8.1 framework. The Franklin County Data Center, operating under the authority of Ohio Revised Code §307.84 and in collaboration with partner agencies, will manage this program, policies, and governance measures to ensure compliance with these standards.

The high-level structure of the Franklin County Cybersecurity Program Framework Standard is based on the following NIST CSF 2.0 functions:

- 4.1. **Govern**: Establish, communicate, and monitor cybersecurity risk management strategy.
- 4.2. **Identify**: Ensure that current cybersecurity risks are understood, including an understanding of organizational assets such as data, hardware, software, systems, facilities, services, personnel, suppliers, and related risks.
- 4.3. **Protect**: Implement safeguards to manage the organization's cybersecurity risks.
- 4.4. **Detect**: Identify possible cybersecurity threats and breaches.
- 4.5. **Respond**: Address any identified cybersecurity incident promptly.
- 4.6. **Recover**: Recover the assets and restore operations affected by a cybersecurity incident.

5. Enterprise Controls

The following enterprise controls establish the information security baseline that supports the program's core functions in addressing ongoing cybersecurity risks. These controls will be prioritized and implemented in accordance with the guidance of the CIS Controls Framework.³

- 5.1. **Inventory and Control of Enterprise Assets**: Actively manage (inventory, track, and correct) all enterprise assets (end-user devices, including portable and mobile; network devices; non-computing/Internet of Things (IoT) devices; and servers) connected to the infrastructure physically, virtually, remotely, and those within cloud environments, to accurately know the totality of assets that need to be monitored and protected within the enterprise. This will also support the identification of unauthorized and unmanaged assets to remove or remediate.
- 5.2. **Inventory and Control of Software Assets**: Effectively manage all software on the network by tracking, correcting, and ensuring only authorized operating systems and applications are installed and allowed to run. Unauthorized and unmanaged software must be detected and blocked from installation or execution.
- 5.3. **Data Protection**: Establish processes and technical controls to identify, classify, securely manage, retain, and dispose of data.
- 5.4. **Secure Configuration of Enterprise Assets and Software**: Establish and maintain secure configuration standards for enterprise assets, including end-

user devices (both portable and mobile), network devices, non-computing/IoT devices, and servers, as well as software such as operating systems and applications.

- 5.5. **Account Management:** Utilize processes and tools to assign and manage authorization for user accounts, including administrator and service accounts, to access enterprise assets and software.
- 5.6. **Access Control Management:** Use processes and tools to create, assign, manage, and revoke access credentials and privileges for user, administrator, and service accounts for enterprise assets and software.
- 5.7. **Continuous Vulnerability Management:** Continuously assess and track vulnerabilities across all enterprise assets within the enterprise's infrastructure, to remediate and minimize the window of opportunity for attackers. Monitor public and private industry sources for new threat and vulnerability information.
- 5.8. **Audit Log Management:** Collect, alert, review, and retain audit logs of events that could help detect, understand, or recover from an attack.
- 5.9. **Email and Web Browser Protections:** Implement protections and detections against threats from email and web vectors. The Data Center will offer this protection as a service to the entities it supports with infrastructure.
- 5.10. **Malware Defenses:** Prevent or control the installation, spread, and execution of malicious applications, code, or scripts on enterprise assets. The Data Center will implement malware defenses at the enterprise level for the infrastructure under its responsibility.
- 5.11. **Data Recovery:** Maintain data recovery practices sufficient to restore in-scope enterprise assets to a pre-incident and trusted state.
- 5.12. **Network Infrastructure Management:** Implement and actively manage network devices to prevent attackers from exploiting vulnerable services and access points.
- 5.13. **Network Monitoring and Defense:** Establish and maintain thorough network monitoring and defense mechanisms to protect against security threats across the enterprise's network infrastructure and user base. The Data Center will implement network monitoring and defense services at the enterprise level to support the infrastructure it oversees.
- 5.14. **Cybersecurity Awareness and Skills Training:** Implement a comprehensive security awareness program to promote a culture of security consciousness among employees and ensure they have the necessary skills to mitigate cybersecurity risks within the organization. The Data Center will provide foundational cybersecurity awareness and skills training for the agencies it oversees. It is also recommended to incorporate additional training as needed, tailored to specific technologies or job functions.

- 5.15. Service Provider Management:** Assess service providers that manage sensitive data or critical IT platforms to ensure they adequately protect those assets.
- 5.16. Application Software Security:** Proactively manage the security lifecycle of internally developed, hosted, or acquired software to prevent, detect, and remediate security vulnerabilities before they impact the enterprise.
- 5.17. Incident Response Management:** Establish a comprehensive capability for incident response that encompasses policies, plans, procedures, defined roles, training, and communication methods to prepare for, detect, and respond promptly to attacks.
- 5.18. Penetration Testing:** Evaluate the effectiveness and resilience of enterprise assets by identifying and exploiting weaknesses in controls, including personnel, processes, and technology, while simulating the objectives and actions of an attacker.

6. Responsibilities

The Data Center will create and maintain documentation that defines the responsibilities of both the Data Center and individual Agencies, Courts, and Boards (Agencies) in implementing these controls. Agencies managing their own technology infrastructure, data, and domains that are not overseen by the Data Center are responsible for implementing controls and ensuring compliance with program standards as required by law.

7. Exception Process

The Data Center will implement a process to ensure that exception requests are reviewed and tracked centrally. These exceptions will undergo review at least once a year.

8. Assessments and Metrics

The Data Center will establish and maintain assessment processes and performance metrics to enhance governance activities and prioritize risks within the Franklin County Cybersecurity Program Framework. All agencies are expected to collaborate with the Data Center in this initiative. Each agency must report its compliance with all framework requirements to the Data Center. Agencies that manage their own technology infrastructure, data, and domains are responsible for their own control assessments; however, they may choose to collaborate with the Data Center on these efforts if they wish.

9. Incident Reporting and Ransomware Payments

Cybersecurity incidents, as defined by ORC §9.64, must be reported to the following entities in the State of Ohio within specific timeframes:

Department of Public Safety: report within 7 days.

Auditor of State: report within 30 days.

Additionally, any ransomware payments require formal approval from the legislative authority.

10. Implementation Guidance

The initial adoption of this framework at the program level is determined by the effective date of this standard. However, Franklin County will need additional time and resources to implement the necessary policies, procedures, standards, and software to comply with the controls outlined in this framework. The Data Center will create policies and standards that detail the implementation requirements and timelines for each specific control. Compliance procedures from the Auditor of State are currently being developed to align with the Ohio Compliance Supplement.

Business Justification

Franklin County provides many of our services, programs, and activities through websites and mobile apps. When these websites and mobile apps are not accessible, they can create barriers for people with disabilities.

Under Title II of the ADA, for web and mobile app accessibility, Franklin County websites, mobile apps, and the documents and services associated with them must meet specific requirements by April 24, 2026. If this deadline is not met, fines and lawsuits are a possibility.

Description

During a 14-week engagement, the consultant will perform both automated and manual audits of the environment to ensure ADA requirements and readability standards are met.

The consultant will review content and information architecture for accessibility and usability. They will confirm the presence and clarity of navigational and accessibility elements such as headers and alt text. Reviews content for plain language, bulleted lists, short sentences and paragraphs, and other writing elements that help people understand complex subjects and navigate important tasks.

A recommendation and strategy will be provided regarding next steps and how to successfully deploy a program for the future that ensures all Franklin County residents have access to the information and services they deserve.

The Data Center will work closely with the vendor to obtain audit information and recommendations as they become available, allowing for corrective action to be taken as quickly as possible.


